The annual income tax fee includes the following services:

- Registration as a taxpayer (where required)
- First provisional tax return
- Second provisional tax return
- Third provisional tax calculation (where applicable)
- Completion and submission of tax returns including uploading of source documentation
- Reconciliation of tax assessment
- Attending to any general query from SARS

More complex queries such as special responses to the South African Revenue Service (SARS), SARS desk reviews or audits and objections due to incorrect assessments by SARS will incur an additional fee subject to the ad hoc service rates below.
