HOW IT WORKS ON THE APP*

The service is available to all Nedbank (SA) clients who receive payments from an international bank.

1 Give the sender the following details	<ul style="list-style-type: none">• Your current account name• Your current account number• Nedbank's SWIFT code: NEDSZAJJ
2 Look out for a confirmation email	We will email you, confirming that we have received your inward payment and that it is now ready for processing.
3 Accept the payment	<ul style="list-style-type: none">• Log in to the app.• Go to International banking and travel on your dashboard.• Expand the tab and choose International payments.• Select the relevant payment and follow a few easy steps to complete the payment.• You have up to 30 days to accept the payment. If you don't accept it, the payment will be returned to the sender.

OTHER FEATURES OF THIS SERVICE

- View the details of all inward payments.
- View the number of days left to accept a payment.
- Select the reason for outward payments.

WHO PAYS FOR THE TRANSFER?

The sender chooses who will pay the transfer charges by selecting one of the following options:

- OUR: All fees are charged to the sender.
 - SHA: The charges are split between the sender and receiver.
 - BEN: All fees are charged to the receiver.
- Exchange control regulations apply.

**TIMELINES FOR SUBMITTING INSTRUCTIONS FOR TRANSACTIONS

- Transactions of more than R1 million: weekdays between 07:30 and 19:00.
- Transactions up to R1 million: weekdays, weekends and public holidays. Transactions submitted after business hours (between 19:00 and 7:30) on weekdays, on public holidays and on weekends will however only be processed on the next business day.
